Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Contner, Muir, Rudolph. Motion by Contner, second by Bardole to approve the agenda. Motion carried unanimously. Motion by Rudolph, second by Burkett to approve the minutes of October 16, 2017. Motion carried unanimously.

Chuck Wenthold reported attending a Beaver Creek Watershed meeting on behalf of the board. Victoria Riley, member of the Courthouse 100 committee, reported that courthouse tours are being given all week in honor of the one hundred year anniversary of the courthouse. Auditor Jane Heun reported that a steeplejack painted the flagpole atop the courthouse last week.

Supervisor Mick Burkett reported participating in interviews for three Secondary Road positions. Supervisor Dawn Rudolph reported attending a Decat meeting and a Heart of Iowa region meeting last week at which notice of the county's intended departure from the region was given. Supervisor Peter Bardole reported attending a GCDC meeting. Chair John Muir reported attending an open house in the Dallas County Recorder's office for a demonstration of Cott Systems, Inc.'s indexing systems for recording, imaging and searching public records. The demonstration was also attended by auditor, recorder and IT personnel from Greene County.

Terry Johnson, Genesis Development CEO, gave a short update regarding the organization's services and funding, noting upcoming changes to a tier system with Medicaid. After his update, Johnson asked the board about its reason(s) for the decision to leave the Heart of Iowa community services region, explaining how that decision might adversely affect Genesis Development, particularly the Hope Wellness Center in Woodward which is operated by his organization.

Motion by Rudolph, second by Burkett to approve satisfaction of forgivable mortgage release document for a down payment assistance property. Motion carried unanimously.

Motion by Bardole, second by Rudolph to approve Resolution 2017-36 transferring funds:

WHEREAS the Greene County Board of Supervisors has set funding transfers in its fiscal 2018 budget,

THEREFORE BE IT RESOLVED that the Board, in accordance with Iowa Code 331.432, authorizes transfers of \$552,500 from the Rural fund and \$162,500 from the LOSST fund, both to the Secondary Roads fund; \$15,000 from the General fund to the Election Equipment fund; and \$5,000 from the LOSST fund to the Capital Projects (Bike Trail) fund.

Roll call: Aye: Bardole, Contner, Muir, Rudolph, Burkett. Resolution approved unanimously.

Motion by Burkett, second by Contner to approve Resolution 2017-37:

BE IT RESOLVED that the job classifications of Secondary Roads employees Scott Beaman and Mike Ostendorf, effective October 16, 2017, are changed from Mechanic II and Equipment III, respectively, to Maintenance II at a rate of \$21.33 per hour plus longevity pay.

Roll call: Aye: Bardole, Burkett, Rudolph, Contner, Muir. Resolution approved unanimously.

Engineer Wade Weiss reporting holding interviews for three openings in his department last week, a US30 Coalition meeting, a road issues. Weiss also discussed repairs needed to the roof of the bell tower.

Motion by Contner, second by Rudolph to approve claims for payment. Motion carried unanimously.

After reviewing items to be included in the county's upcoming budget amendment hearing, Chair Muir adjourned the meeting at 10:05 a.m.
