Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Contner, Muir, Rudolph. Motion by Contner, second by Burkett to approve the agenda. Motion carried unanimously. Motion by Bardole, second by Burkett to approve the minutes of October 23, 2017. Motion carried unanimously.

Supervisor Dawn Rudolph reported on a fundraiser to support Freedom Rock maintenance. Chair John Muir reported on the Courthouse 100 year anniversary celebration held last week.

Main Street director Peg Raney, accompanied by Jefferson city administrator Mike Palmer and mayor Craig Berry were present to provide background information in the form of a PowerPoint presentation for the Wayfinding signage to be used for Jefferson. Raney described in detail the steps that had been taken and the groups who were involved in reaching the final signage proposal. Board members expressed their concerns about identifying the "courthouse square" as the "bell tower square" as it is referenced in the new signage. No action was taken on the matter.

Motion by Contner, second by Bardole to approve a letter of support to Grow Greene County on behalf of the Jefferson Police Department grant application. Motion carried unanimously.

Motion by Burkett, second by Rudolph to approve Resolution 2017-39 as follows:

BE IT RESOLVED that the Greene County Board of Supervisors approves hiring Brandon Turner as full time deputy sheriff effective November 22, 2017, at a rate of \$40,000 per year until certified. Salary will increase to \$42,500 after certification.

Roll call: Aye: Bardole, Burkett, Contner, Muir, Rudolph. Resolution approved unanimously.

The agenda item concerning an increase for deputy Christopher Frehse was tabled.

Motion by Contner, second by Bardole to appoint Dennis Morlan, as representative of the county's emergency management commission, to the E911 board. Motion carried unanimously.

Engineer Wade Weiss reported to the board. Supervisor Tom Contner departed the meeting at 9:45 a.m.

Chris Whitaker of Region XII COG explained that a previously approved local match resolution (2017-22 on June 5, 2017) for a hazard mitigation grant program in Greene County has been rewritten to include additional jurisdictions, i.e., other counties. Whitaker explained that the grant requires a cash (local) match from the county. Motion by Rudolph, second by Burkett to approve Resolution 2017-38:

WHEREAS Greene County has made application, in cooperation with Crawford, Carroll, and Sac Counties, through the Iowa Homeland Security and Emergency Management Division (HSEMD) to the Federal Emergency Management Agency (FEMA) for funding from the Pre-disaster Mitigation Grant Program, in the amount of \$66,750 for the total project cost, and

WHEREAS the Subgrantee recognizes the fact that this grant is based on a cost share basis with the federal share not exceeding 75%, the state share not exceeding 0% and the local share being a minimum of 25% of the total project cost. The minimum 25% local share can be either cash or in-kind match, and

THEREFORE Greene County agrees to provide and make available up to \$4,375 of local monies to be used to meet the minimum 25% match requirement for this mitigation grant application.
