

December 18, 2017

Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Contner, Muir, Rudolph. Motion by Contner, second by Bardole to approve the agenda. Motion carried unanimously. Motion by Burkett, second by Rudolph to approve the minutes of the De

ember 11, 2017 and December 14, 2017 meetings. Motion carried unanimously.

Supervisor Tom Contner reported attending a New Opportunities meeting. Supervisor Peter Bardole reported attending a Central Iowa Juvenile Detention meeting. Supervisor Dawn Rudolph reported on a Mental Health Coalition meeting at the Greene County Medical Center. Chuck Wenthold reported on attending a North Raccoon Watershed meeting. Sheriff Jack Williams updated the board on the auction that was held for towed vehicles. Supervisor Mick Burkett reported on a 2nd Judicial District meeting that he attended. Sheriff Jack Williams and Chief Deputy Nathaniel Chapman reported attending a class on drones. They hope to be certified next month.

Jeff Lamoureux of Habitat for Humanity gave a report of Habitat's Helping Hands home repair program. Six homes were repaired through this project last year. They plan to continue this program in 2018. Lamoureux requested continued support of \$5,000. No action was taken.

Cherie Cerveny, Donna Sutton and Cindy Daubendiek representing Greene County Early Learning Center presented their funding request for FY19 in the amount of \$5,000. Currently they have 23 total employees, 12 full-time and the rest part-time, plus they have volunteers. Current enrollment is at 100 children with 18 on a waiting list. They also reported to the board that they have received 6 grants totaling \$34,000. No action was taken.

Doug Hawn and members of the Greene County Fair Association board were present for the fair association's FY19 budget request. Hawn provided a detailed financial report and event summaries report to the board and noted that, as in past years, no increase was being requested for FY19. Funding is currently \$24,000 and has been since fiscal 2012. No action was taken.

Motion by Contner, second by Burkett to accept the Treasurer's Investment & Driver's License Report for November. Motion carried unanimously.

Engineer Wade Weiss provided the board with plans of Proposed Improvement FM-CO37(75)-55-37 Co. Rd. E18 over West Buttrick Creek. Motion by Contner, second by Rudolph to approve the plans. Motion carried unanimously. Weiss also reviewed the 2017 Yearly State Weed Commissioner Report. Motion by Burkett, second by Contner to approve the 2017 Weed Commissioners Report. Motion carried unanimously.

Chair Muir adjourned the meeting at 10:35 a.m.
