Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Contner, Muir, Rudolph. Motion by Bardole, second by Contner to approve the agenda. Motion carried unanimously. Motion by Rudolph, second by Burkett to approve the minutes of December 3, 2018. Motion carried unanimously.

Chair John Muir reported attending the annual IDDA meeting in Fort Dodge as a drainage district trustee representative. Supervisor Dawn Rudolph reported for a Greene County Public Health meeting held last week.

Motion by Contner, second by Bardole to approve claims for payment. Motion carried unanimously.

Jefferson city administrator Mike Palmer presented an update of city activities and projects.

Jeff Lamoureux, Habitat for Humanity, reported past year Helping Hands projects in the county, providing before & after project completion photos. Three repair and maintenance projects were described as well as one accessible ramp project for local recipients. Lamoureux reported Habitat's assistance to homeowners in accessing USDA rural development grants & loans. Lamoureux requested \$5,000 support again for FY20 for the Helping Hands program. No action was taken.

Motion by Burkett, second by Rudolph to accept the Recorder's Report of Fees for November. Motion carried unanimously.

Motion by Burkett, second by Contner to approve Resolution 2018-32 for employee job classification and pay rate changes:

BE IT RESOLVED that the Board of Supervisors, effective December 1, 2018, approves appointing Ryan Baugh to Shop Superintendent at \$25.76/hour; this position does not qualify for longevity increases, and

BE IT RESOLVED that the Board of Supervisors, effective December 1, 2018, approves appointing Kevin Bauer to Fabrication Shop Superintendent at \$25.76/hour; this position does not qualify for longevity increases, and

BE IT RESOLVED that the Board of Supervisors, effective December 1, 2018, approves appointing Tanner Stauffer to Assistant to the Engineer at \$62,000/year; this position does not qualify for longevity increases.

Roll call vote: Aye: Bardole, Burkett, Contner, Muir, Rudolph. Resolution approved unanimously.

A resolution to approve a full-time sheriff's deputy was tabled until additional information regarding contract payoff with the city of Jefferson is determined.

Roger Aegerter, Greene County Historical Society, reviewed the events of the past year and the number of volunteer hours involved during the past year. The Smithsonian Institution's Museum on Main Street Exhibit - Hometown Teams was shared with local school kids and was very popular. Aegerter discussed ceiling maintenance and upgrading accessibility to the museum in his request for \$10,000 for FY20. Current year funding is \$6,000. No action was taken.

Engineer Wade Weiss received informal approval for overnight travel.

Muir adjourned the meeting at 9:50 a.m.
