Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Contner, Muir, Rudolph. Motion by Contner, second by Bardole to approve the agenda. Motion carried unanimously. Motion by Burkett, second by Rudolph to approve the minutes of January 30, 2020. Motion carried unanimously.

At 9:00 a.m. Chair John Muir opened a public hearing for comments on the proposed FY21 Emergency Management Commission budget. The proposed budget includes a \$32,000 contribution from the county and \$1,000 in ICAP grant revenue. Proposed expenditures total \$34,283, with an estimated fund balance of \$6,688 at the beginning of the fiscal year, and \$5,405 at year end. No oral or written objections were made. Motion by Bardole, second by Contner to close the hearing. Motion carried unanimously. Motion by Burkett, second by Contner to approve Resolution 2020-08:

WHEREAS a hearing concerning the proposed FY21 Emergency Management budget has been held in accordance with Chapter 29C.17 of the Code of Iowa; and,
WHEREAS no written or oral objections have been received on the proposed budget;
THEREFORE BE IT RESOLVED that the Greene County Board of Supervisors, acting as the Greene County Emergency Management Commission, adopts the FY21 Emergency management budget.

Aye: Bardole, Burkett, Contner, Muir, Rudolph. Resolution unanimously approved.

Chamaine Sims, Mentoring/Prevention Assistant with New Opportunities, shared information with the board about the Fun Friends Mentoring program offered in Audubon, Carroll, Greene, Guthrie and Sac counties. The program is offered for children in kindergarten through age 18. Mentors, once approved for the program, may participate as few as four hours per month. Youth participating in the program have no eligibility requirements and may benefit greatly from the mentoring experience. Sims' goal is to get the word out about the program, to increase numbers and find mentors. Currently Greene County has two matches (mentor/mentee) and five children on a waiting list.

Engineer Wade Weiss reported communication with Holly Elbert from Brooks Borg Skiles to have BBS recommend cooling options for the Bell Tower observation deck. Elbert also recommended the county consider suspending the balance of the contract on the courthouse HVAC and window replacement design services for the time being.

The remainder of the board's time was spent reviewing proposed departmental budgets and funding requests from outside organizations (discretionary funding requests) to determine amounts to be included in the proposed FY21 budget.

Muir adjourned the meeting at 11:10 a.m.
