GREENE COUNTY CITY ELECTIONS**

The City Election for the Cities of **Churdan, Dana, Grand Junction, Jefferson, Paton, Rippey and Scranton** in the County of Greene, will be held Tuesday, November 3, 2015 for the purpose of electing Mayors and City Council Members. The City of Scranton will also be voting on changing the membership of Library Board of Trustees and terms.

The **Churdan Precinct**, consisting of voters within the corporate city limits of Churdan, Greene County, Iowa will vote at the Community Center in Churdan, Iowa.

The **Dana Precinct**, consisting of voters within the corporate city limits of Dana, Greene County, Iowa will vote at St. Brigid Parish Center, Grand Junction, Iowa.

The **Grand Junction Precinct**, consisting of voters within the corporate city limits of Grand Junction, Greene County, Iowa will vote at St. Brigid Parish Center, Grand Junction, Iowa.

The **Jefferson 1 Precinct**, consisting of voters within the corporate city limits of Jefferson and located mostly east of Wilson St. and south of Perry St. will vote in the south rotunda of the Greene County Courthouse, Jefferson, Iowa.

The **Jefferson 2 Precinct**, consisting of voters within the corporate city limits of Jefferson and located mostly north of Westwood Dr. (from western edge of precinct, which includes Lincoln Ridge Estates) to High St; north of Lincolnway from High St. to Wilson St.; north of Perry St. from Wilson St. on east will vote at Trinity Lutheran Church, Jefferson, Iowa.

The **Jefferson 3 Precinct**, consisting of voters within the corporate city limits of Jefferson and located mostly south of Westwood Dr. (from the western edge of Precinct) to High St; south of Lincolnway from High St. to Wilson St. mostly west of Wilson St. will vote at the Greene County Community Center, Jefferson, Iowa.

The **Paton Precinct**, consisting of voters within the corporate city limits of Paton, Greene County, Iowa will vote at the Shriver Community Bldg. in Paton, Iowa.

The **Rippey Precinct**, consisting of voters within the corporate city limits of Rippey, Greene County, Iowa will vote at the Rippey Library/Community Room in Rippey, Iowa.

The **Scranton Precinct**, consisting of voters within the corporate city limits of Scranton, Greene County, Iowa will vote at the "New" Scranton City Hall in Scranton, Iowa.

The polling places will be open from 12:00 p.m. until 8:00 p.m.
