The Greene County Board of Supervisors met at 9:00 a.m. in the courthouse boardroom with the following members present: Bardole, Benitz, Burkett, Muir, Rudolph. Motion by Bardole, second by Benitz to approve the agenda. Motion carried unanimously. Motion by Bardole, second by Benitz to approve the minutes of March 25, 2024. Motion carried unanimously.

Supervisors reported on meetings attended. Supervisor Benitz attended New Opportunities. Supervisor Bardole attended Jefferson Matters.

Overnight travel was informally approved for Heath Enns to attend Lien School in Des Moines.

Attorney Thomas Laehn addressed an e-mail the board and he received concerning the proposed amendments to the Solar Ordinance.

Engineer Wade Weiss updated the board on final numbers for the P57 paving project and other paving projects. He also gave the board an updated timeframe and costs for the HVAC project. This timeframe didn't take into consideration that the proposition failed at the March 5, 2024, Special Election.

Motion by Rudolph, seconded by Burkett to set the public hearing for the FY25 Proposed County Budget on April 22, 2024, at 9:00 a.m. Motion carried unanimously.

Attorney Thomas Laehn reviewed the Open Meetings Policy with the revisions that were made at a previous meeting. Motion by Burkett, seconded by Bardole to approve the Open Meeting Policy. Motion carried unanimously.

Motion by Benitz, seconded by Rudolph to approve the family farm credit disallowances reviewed by the board. Motion carried unanimously.

Motion by Bardole, seconded by Benitz to approve Resolution 2024-013 for Recorder Office Full-time hire.

BE IT RESOLVED that the Greene County Board of Supervisors approves the hiring of Katie Fisher as a full-time Clerk for the Greene County Recorders office and will be paid a yearly salary of \$48,500 effective July 1, 2024. Upon completion of a 6-month probationary period, and with a favorable review, she will be named Greene County Deputy Recorder at 65.5% of the Recorder's Salary which will be \$50,460.55.

Motion by Rudolph, seconded by Burkett to approve the awarding of Iowa Department of Transportation Contract ID: 25-CO25-126, including work on County Highway P-46 in both Greene (FM-C037(79)-55-37 and Dallas (HSIP-SWAP-CO25(126)-FJ-25) Counties, and approving Dallas County as the Contracting Authority. Motion carried unanimously.

Motion by Bardole, seconded by Benitz to approve the auditor signing of E911 checks. Motion carried unanimously.
